Sustainable Energy Cost

The ICSE-PR will be the leading private sector watchdog to assure credibility, achievability of Fiscal Board mandated \$0.21 cents / kwhr average tariff costs.

The ICSE-PR will support all regulated initiatives that allow better than \$0.21 c/kwhr residential, commercial and industrial energy costs privately owned and financed under regulated utility standards.

Broad Strengthening or our local Independent Regulatory Framework

ICSE-PR will be leading NGO educator of Best Practices utility regulated standards in collaboration with federal and local government.

ICSE-PR will be leading private sector advocate for PR Energy Commission budget in harmony with challenges and opportunities for reform to regula- ted utility standards, including professionally selected non-partisan commissioners.

INDEPENDENT REGULATORY STRENGTHENING

Sept 23, the Puerto Rico (Utility) Energy Commission approved a Modified Integrated Recourses Plan, an IRP that includes most of ICSE-PR recommendations as approved Intervenor to all PREC regulatory proceedings.

\$570 MILLION ANNUAL COST REDUCTION

August 17 ICSE-PR led a Group with Manufacturers Association and eight (8) other NGO's representing 80% of the private sector in San Juan State Court to contest the Transition Changes to halt PREPA of 3.10 Cent/KWh added rate, presently eliminated—along with a reduction of PREPA proposed tariff increase to PREC a total average tariff reduction of 15% to all rate payers.

What we would be paying as proposed by PREPA

23.3¢/KWh \$4,023 mill annual

What we are paying now, after ICSE-PR Intervention

20¢/KWh \$3,453 mill annual
